Note:

- You must familiarise yourself with the Slipway health and safety requirements and gale warning procedures. If unsure of any requirements please ask the Slipmaster.
- The Slipmaster must be advised in writing as soon as it is apparent that extra time is required.
- Boat Owners must give the Slipmaster as much advance notice as possible (not less than 48 hours) as to when the Boat will be ready to be re-launched. Operational requirements may mean your request cannot always be accommodated.
- No Cash, No Splash. A valid Club receipt for all haul out and hard storage fees must be produced prior to relaunching. Your Boat will not be re-launched, and fees will continue to accrue, until such a receipt is produced.
- Debts will incur interest and any associated debt recovery costs. Interest will be charged at a rate determined from time to time by the Club Management Committee.
